WELCOME

The future of Europe is decided in Ukraine. Supporting Ukraine in defending its sovereignty and territorial integrity, its Euro-Atlantic integration and reconstruction - three inter-related goals - is an investment in the future of the European project. 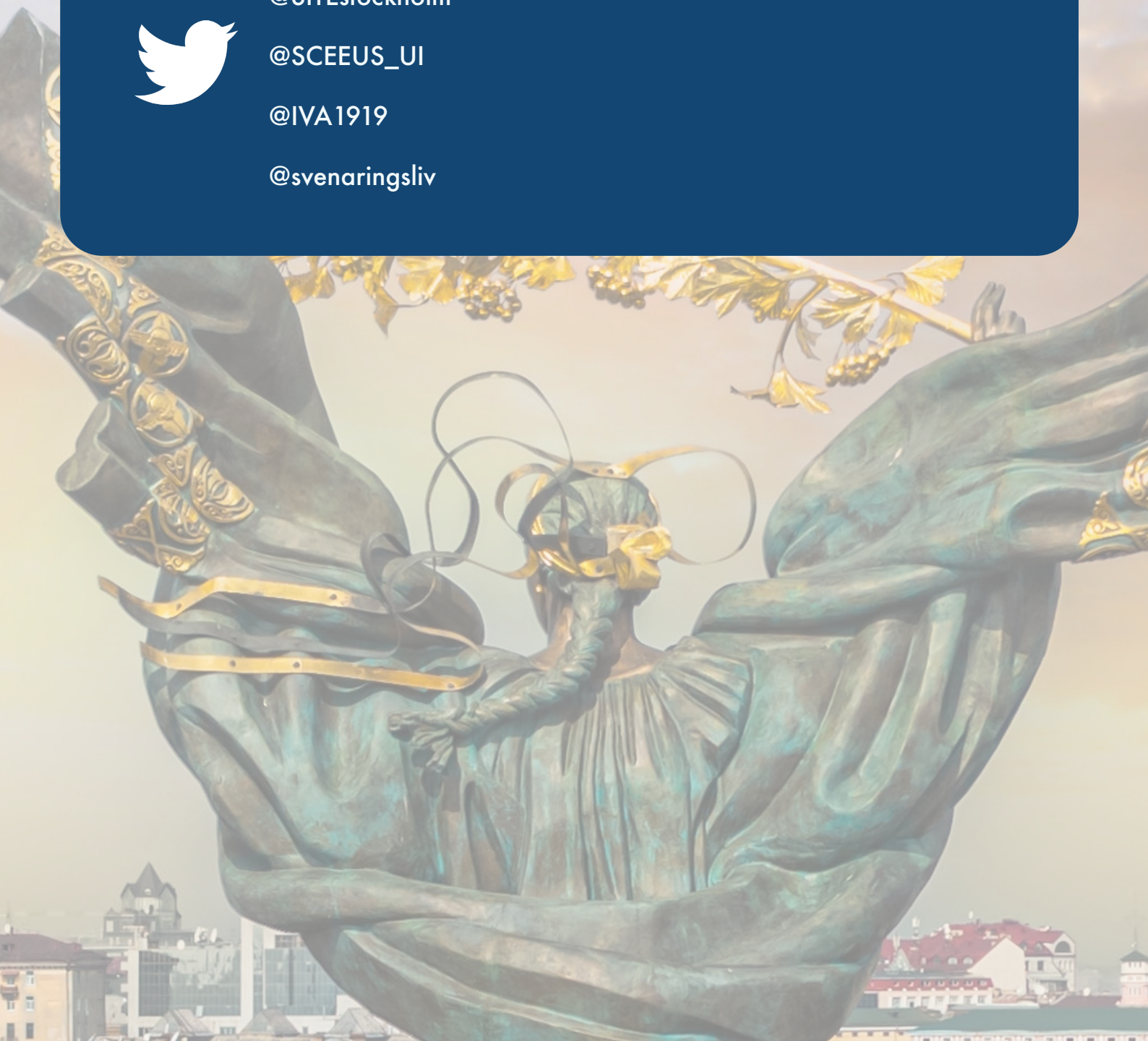
